

# Terms & Conditions - Eastland Father's Day Promotion 2010

1. The promotion is called 'Spend \$50 and receive a FREE mini tool set for Dad this Father's Day'.
2. Information on how to participate forms part of these terms and conditions.
3. These terms and conditions relate to Eastland's Father's Day Promotion 2010. The promoter is Eastland Shopping Centre.
4. The Eastland Father's Day Promotion commences Monday 30<sup>th</sup> August and is **only available while stocks last. One giveaway per household, per day.**
5. Customers who spend \$50 or more in any store within the Centre excluding Coles, Woolworths, utility and telecommunications payments, or on an Eastland Gift Card are entitled to receive a mini tool set on the day of the purchase. Purchases of gift vouchers/gift cards and/or lay by purchases from stores listed are not eligible for the gift.
6. Customers must produce original receipts as a proof of purchase to redeem their gift and receipts will be stamped. Once a receipt is presented it will be cancelled with an Eastland stamp and may not be reused for further giveaways even if the amount of the receipt is for an amount over \$50. You will receive one mini tool set per household, per day for minimum \$50 spent.
7. To be eligible for the gift, the customer must present original receipts dated the same day they receive the gift (e.g: If items are purchased on Monday 30<sup>th</sup> August 2010, the customer is only eligible to receive the special offer on Monday 30<sup>th</sup> August 2010).
